TERMS AND CONDITIONS

Please read the following terms and conditions carefully

1. GENERAL TERMS AND CONDITIONS

This document is published in accordance with the provisions of Rule 3 (1) of the Information Technology (Intermediaries guidelines) Rules, 2011 that require publishing the rules and regulations, privacy policy and Terms of Use for access or usage of Amble Mobile App. Amble Mobile App (hereinafter referred to as "Mobile App") is owned by RPG Foundation (RPGF) a registered Public Charitable Trust under the Bombay Public Trust, 1950. Foundation social intervention is majorly funded by CSR fund of RPG Group of companies. Your use of the Mobile App and services and tools are governed by the following terms and conditions ("Terms of Use") as applicable to the Mobile App including the applicable policies which are incorporated herein by way of reference. By accessing the Mobile App, You agree to be bound by these Terms, so please read these Terms carefully before continuing to use this Mobile App. If you do NOT agree with any of these Terms, please do not use this App. These Terms constitute a legally binding agreement ("Agreement") between you and the RPG Foundation ("Company") regarding your use of the Mobile App i.e., Amble.

You also acknowledge and agree that we may modify this Agreement at any time, at our sole discretion; that all modifications to this Agreement will be effective immediately upon our posting of the modifications on the Mobile App; and that you will review this Agreement each time you access this site, so that you are aware of and agree to any and all modifications made to this Agreement. Your use of the Mobile App after any amendment to the Terms of Use shall constitute your acceptance of these terms and you also agree to be bound by any such changes/revisions. You also acknowledge and agree that, unless we specifically provide otherwise, this Agreement only applies to this Mobile App and our online activities and does not apply to any of our offline activities. If you access the Mobile App, you shall be subject to the policies that are applicable to the Mobile App as on date. For the purpose of these Terms of Use, wherever the context so requires "You" or "User" shall mean any natural or legal person who has agreed to become a user of the Mobile App by providing Registration Data while registering on the Mobile App as Registered User using the computer systems and/or mobile phones. The Mobile App, Amble, a heritage walks mobile application endorsed by Maharashtra Tourism

Development Corporation (MTDC) and Municipal Corporation of Greater Mumbai (MCGM), aims at facilitating accessibility and an enhanced experience of our heritage. The Mobile App exhibits information on self-guided walking routes and Augmented Reality experiences in and around Mumbai. The term "We", "Us", "Our" shall mean RPG Foundation.

2. GENERAL CONTENTS

2.1. Self-guided walking routes and Augmented Reality (AR) experience

2.1.1. The Mobile App provides a range of self-guided walks within Mumbai with the aim of making cultural and heritage tourism of Mumbai accessible to all

2.1.2. Each walking route comprises of around 8-15 points of interest whose historic and cultural significance has been explained

2.1.3. The description is based on extensive research and we do not warrant the accuracy of the content

2.1.4. The Mobile App also features Augmented Reality (AR) experiences for some and not all walks

2.1.5. The content as well as the AR experience does not intend to disrespect, impair, or disparage the beliefs, feelings, sentiments of any person(s), community(ies), culture(s), practice(s) and tradition(s)

2.2. We attempt to keep the Content of the Mobile App up to date. You acknowledge that the Content on the Mobile App is subject to change at any time. Further, you also acknowledge that the underlying infrastructure and/or technology supporting the Mobile App is subject to change at any time.

2.3. The views which are expressed by members of the public who have uploaded Content to the Mobile App are not our views, and we accept no liability in respect of any Content posted on the Mobile App by third parties, nor are we responsible for its content or accuracy. Any reliance you place on Content posted on the Mobile App is at your own risk.

2.4.  - Your preferences on tour/heritage walks
 - Recommendations on making the application more effective and efficient
 - Other data collected that could directly or indirectly identify you
- 3.2. We collect information from you when you fill out a form or enter information on the Mobile App. Information pertaining to preferences and recommendations for improvement may be collected while you use our services.
- 3.3. We may use the information we collect from you when you register or sign up for our services, respond to a survey or marketing communication, surf the website, or use certain other site features in the following ways:
 - 3.3.1. To follow up after correspondence (live chat, email or phone inquiries)
 - 3.3.2. Respond to your queries or questions
 - 3.3.3. To allow us to deliver the type of content and product offerings in which you are most interested
 - 3.3.4. Measure interest in and improve our services to better serve you
 - 3.3.5. To allow you to subscribe to our newsletter
 - 3.3.6. From time to time, we may offer special promotions (such as a contest or a free subscription to goods and services) on the application in association with a third-party service provider, sponsor or promotional partner.
